BARTLETT SCHOOL DISTRICT WARRANT STATE OF NEW HAMPSHIRE

To the Inhabitants of the School District of Bartlett, in the County of Carroll, State of New Hampshire, qualified to vote on District affairs:

You are hereby notified to meet at the Josiah Bartlett Elementary School gymnasium in said District on Tuesday, March 5, 2024 at 6:30 in the evening to act upon the following subjects:

ARTICLE 1: To see if the school district will vote to raise and appropriate the sum of \$8,616,892 for the support of schools, for the payment of salaries for school district officials and agents, and for the payment of statutory obligations of the district, with \$145,500 offsetting this amount from various grants. This article does not include appropriations voted in other warrant articles. (Majority vote required) (Recommended by the School Board 5-0-0)

ARTICLE 2: To see if the School District will vote to approve the cost items included in the collective bargaining agreement reached between the Bartlett School Board and the Bartlett Education Association which calls for the following increases in salaries and benefits at the current staffing levels:

2024-25	\$104,881
2025-26	\$103,169
2026-27	\$95,404

and further to raise and appropriate the sum of \$104,881 for the upcoming fiscal year, such sum representing the additional costs attributable to the increase in salaries and benefits required by the new agreement over those that would be paid at current staffing levels under the existing collective bargaining agreement. (Majority vote required) (Recommended by the School Board 5-0-0)

ARTICLE 3: To see if the School District will vote to raise and appropriate up to \$50,000 to be placed in the Capital Reserve Fund (Special Education), previously established for this purpose. This sum is to come from the June 30 fund balance available for transfer on July 1, 2024. No amount to be raised from taxation. (Majority vote required) (Recommended by the School Board 4-1-0)

ARTICLE 4: To see if the School District will vote to create an expendable maintenance trust fund under the provisions of RSA 198:20-c, to be known as the Maintenance Trust Fund, for the purpose of repairing and maintaining the Josiah Bartlett Elementary School. Furthermore, to raise and appropriate up to fifty thousand dollars (\$50,000) toward this purpose, with such amount to be funded from the year end undesignated fund balance available on July 1, 2024, and to name the school board as agents to expend from this fund. (Designated as a Special Article) (Majority vote required) (Recommended by the School Board 5-0-0)

ARTICLE 5: Petitioned Warrant Article: This is a special petitioned warrant article submitted by a Bartlett voter (supported with requisite signatures). To see if the School District will raise and appropriate \$35,000 to hire a consultant to complete the following studies: energy systems study, lighting transition study, building and weatherization and energy audit, and solar study. (Majority vote required) (Recommended by the School Board 4-1-0)

ARTICLE 6: To transact any other business that may legally come before this meeting.
